

# Paper 3: Report from Healthwatch Rutland Manager

I am pleased to submit this report to the Board of Healthwatch Rutland (HWR), covering the period since my last report in January 2024.

### Healthwatch Rutland Contract

Rutland County Council have extended Healthwatch Rutland's contract with Connected Together CIC until 31 March 2025. This is great news and reflects the hard work and team efforts of Board Members, volunteers and staff – thank you all!

#### **Volunteer News**

The HWR advisory board invited Andrew Nebel to take up a co-opted seat on the board in January. Andrew joined HWR last year as an authorised representative and we are now pleased to welcome him to the board!

#### Healthwatch Dementia Work

The local MP, Alicia Kearns, held a second meeting on 2/2/24 between voluntary sector providers of dementia support in Rutland, ICB, RCC, and HWR. The focus has shifted to a month-long awareness campaign in May, to include advertising and events. We await further plans of what this might look like.

In a separate initiative, through introducing the Admiral Nurse and RISE teams to the Uppingham PPG and other voluntary groups, HWR will be supporting a dementia event in Uppingham at the start of Dementia Action Week on 13 May.

#### Stakeholder Perceptions Survey

The survey has closed, and a draft report is ready to be circulated to the board for discussion at the next Board Development Meeting (date TBA). The report will also be shared with our commissioner, contract holder and Healthwatch England.

#### Work Planning for the year ahead

An initial scoping discussion was held at the February Ops and Planning meeting. We considered the future priorities of local commissioners and providers, areas of our own work that are continuing on from this financial year and possible new areas for engagement going forward. The deliberations will be written up and shared for further consideration and decision by the board in the coming weeks.

In addition to planning our core Healthwatch work, we are in discussion with Rutland County Council about additional commissioned projects which will complement our annual workplan next financial year if agreed.



## Enter and View (E&V)

The Oakham Minor Injuries Unit E&V project is well underway. Volunteer visits took place in February and an online/hardcopy <u>survey</u> is available to widen the scope of patient feedback on their experiences of the service.

The report will be drafted in March.

#### Outreach

During the period since the last board meeting in public HWR has joined coffee mornings at Chater Lodge care home, Lonsdale Park sheltered accommodation and Somerby village hall. A pop-up stand was held at Oakham Castle to raise awareness about HWR, recruit volunteers and listen to public experiences of health and care. In addition, Hollie attended both Men in Sheds and Women in Sheds sessions run by Age UK.

#### **NHS dentistry**

The <u>HWR dental poll report</u> was published last month and shared with stakeholders and commissioners. People told us that they feel they have no choice but to pay for private dentistry even though they can't afford it, with 59% of respondents unable to get an NHS appointment in the last 12 months.

We heard from 123 people and the feedback again highlighted that the people of Rutland need more affordable, accessible dentistry services.

The long-awaited NHS Dental Recovery Plan was announced earlier this month, which proposes various initiatives backed by a £200m budget, with the aim of providing up to 2.5m additional appointments to people across England.

Next steps are to consider how best to present our local evidence to commissioners and stakeholders to help Rutland receive a fair share of the recovery plan effort and funding.

#### Same Day Access / Access at Place

The follow-up meeting to discuss options for a new same-day access model to replace current urgent care and minor injuries clinics has not yet taken place and no updates have been received to date. Dates for the meeting are being sought in March.



### **Ambulance Response Performance**

Slight improvements in Category 1 and 2 response times are noted for Rutland in January, although still poor against mean targets. Category 1 mean response was 12 minutes 29 seconds against the 7-minute target and Category 2 mean response was 59 minutes against the 40-minute target at the mean. There was a notable deterioration in ambulance handovers at the Leicester Royal Infirmary leading to 4373 hours lost to delay. System wide work to improve Category 2 response is subject to close monitoring and actions from within the LLR Urgent and Emergency care partnership. Poor Category 1 response in Rutland is being pursued through the EMAS deep dive into patient outcomes for November that I reported on to the last board meeting. This is intended to help us to understand if there is a real risk to Rutland patients and if any serious incidents have been as a result of slow response. We await the results of this.

Since quarterly meetings between Healthwatch and EMAS had lapsed last year, it has been agreed that EMAS will be asked to report to the Rutland Integrated Delivery Group on a quarterly basis in order to include all Rutland partners in the discussions.
