Moves are being made to redefine the Glenfield Unit catchment area to extend the population numbers feeding into the Heart Unit, thereby bringing the unit increased referrals an increasing its ability to meet national standards.

16.72 Annual Report and Mid-year Report

The publication of the HWR Annual Report in July 2016 was noted.

The Mid-year report would be sent to Rutland County Council on Monday 21st December and any suggested amendments were required immediately.

16.73 Health and Social Care Forward Plans

The Chair briefed the meeting on the Leicester, Leicestershire and Rutland Sustainability and Transformation Plan (STP) process - formerly Better Care Together. A veil of secrecy had been drawn around the process to date and HWR's stance had been one of disappointment at the lack of patient and public involvement in the plan's formulation.

The Plan was expected to be published any day, with HWR's role thereafter to ensure that the public hear the proposals and get ample opportunity to comment. The expectation is that a series of public consultation events would be planned for the New Year.

16.74 Oakham Neighbourhood Plan (ONP) & survey of health services in Rutland

Liz Sanders explained that the nature of Neighbourhood Plans, being community led, has necessitated the committee spending much time and effort on awareness raising in the community in order to obtain good public input. Once all the input is received a 20 year plan will be drawn together.

Health and medical issues have been the largest single proportion of the community feedback received so far. HWR and the ONP committee are collaborating on this element of the plan, which will be taken forward in the first quarter of 2017 with the Primary Care Survey.

Jacqui Thibault expressed concern that primary care services at Oakham Medical Practice (OMP) were over-subscribed and at breaking point now, with in excess of 4000 registered patients over capacity.

It was agreed that a rigorous, evidence-based statement of the problem to the CCG following the survey would offer invaluable help to strengthen the case for action.

Jacqui suggested close liaison between HWR and the Rutland Patient Participation Groups (PPGs) to promote the success of, and maximise feedback from the survey. Sarah Iveson would pull together a meeting to further this.

16.75 Policy and other matters for consideration by Healthwatch Rutland Board

The meeting received an overview from the Chair covering the following policy matters affecting Rutland people. Copies of all the reports are available on request.

1. Settings of Care Policy

The three clinical commissioning groups covering Leicester, Leicestershire and Rutland – East Leicestershire and Rutland, West Leicestershire and Leicester City CCGs – have asked patients, carers, families and the groups that represent them to share their thoughts and views on potential changes to the 'Settings of Care' policy. Those in receipt of Continuing Health Care have been specifically asked their views. The results of the survey are currently being collated and reviewed and will be taken into consideration in the drafting of an updated policy. If significant changes are recommended the CCGs will run a public consultation later in the year.

2.Over the Counter Medicines

From 31 October 2016 the majority of patients in East Leicestershire and Rutland are no longer be prescribed medicines by their GP if they are available over the counter at pharmacies and supermarkets. These medicines will include pain killers, cough medicines, hay fever tablets and cold sore treatments. Some patients will be exempt from this change if they have particular conditions, for example those who need paracetamol to manage chronic pain, and these people are being advised to discuss this with their GP.
