

Paper 5: Report from Healthwatch Rutland Manager

I am pleased to submit this report to the Board of Healthwatch Rutland (HWR), covering the period since my last report to the Board in October 2023.

Healthwatch Dementia Work

The local MP, Alicia Kearns held a meeting on 24/11/23 between voluntary sector providers of dementia support in Rutland, ICB, RCC, the PCN and HWR. Ms Kearns wants to support the county in increasing diagnosis rates by raising people's awareness in the community and encouraging people to come forward for assessment. Her own contribution would be by encouraging businesses around Rutland to have dementia friends training and raising the profile of the assessment services and support on offer. We await her plan of what this might look like.

A separate meeting of voluntary sector groups and dementia service providers was also held in November to ensure that all Rutland service providers are aware of each other and network together to raise public awareness of dementia.

Stakeholder Survey

A request was received to allow more time for the HWR stakeholder survey to be completed by one of our partners; it will now close on 12 January after which date the results will be collated and reported to the board to consider next steps.

Enter and View (E&V)

The <u>report on Oakham Medical Practice</u> was published in November as planned and presented to the public at an open PPG meeting on November 28 2023. The presentation was followed by OMP's responses to our recommendations (which are documented also in our report). The HWR recommendations and the Practice's actions will be monitored during ongoing regular reviews with the practice manager.

Hollie will begin planning our next E&V project in January.

Outreach

During the period since the last board meeting in public HWR pop up events have been held in Uppingham, Oakham, Ketton and Ryhall along with the Greetham Dementia event and Rural Coffee Connect at North Luffenham.



Coming up in January and February, Hollie will be at the <u>Chater Lodge</u> and <u>Tixover House</u> community coffee mornings and <u>Oakham Castle</u> to raise awareness, recruit volunteers and listen to public experiences of health and care.

NHS dentistry

The situation in Rutland remains that there are no practices in Rutland accepting adults and there is limited capacity for children. The Oral Health Needs Assessments in the Midlands region are due anytime now, which will allow regional decisions to be made on procuring new services to replace the loss of the Rutland MyDentist contract that was handed back in 2022.

The HWR Dental poll closed in late November with over 100 responses; the report is being worked on currently.

Same Day Access / Access at Place

The current position is that there is no funding for the Minor Injuries Unit or the out-of-hours Urgent Care Centre in Oakham after March 31, 2025, and a new model of same day access is being sought. In addition, the current offer is confusing for the public and needs to be simplified and understandable. A new proposed model will probably need consulting upon as it will involve changes to services.

A meeting was held by the ICB in late November to restart this work (see my meeting report to the board of 4/12/23) The agreed outcomes of the meeting were:

- That same day access is needed in Rutland outside of GP practice opening, it is not acceptable to close UCC and MIU and refer people out of county.
- Equally, it was accepted that a fully functioning 12-hour x 7-day Urgent Treatment Centre like Corby is not planned for Rutland.
- A single service is to be investigated that covers both daytime and evening/weekends and bank holidays that would cater for both illness and injury across all its opening hours.
- There will be investigation to find out if money for this could be released by taking the x-ray facility out of the same day offer. This would be on the proviso that the 2 days of x-ray at RMH for other UHL & LPT diagnostic/elective work would not be compromised.

The working hypothesis is that a single Rutland based urgent illness and injury service across day and evening/weekend would be simpler for the public to understand, with suspected x-ray/diagnostics need referred to other centres such as Corby,



Stamford etc (as is the case now from Thursday to Monday when the RMH X-ray is not available).

Ambulance Response Performance

Slight ambulance response improvements for Rutland during the summer dropped back again in November with the Category 1 response being over 14 minutes against the target of 7 minutes average.

I raised the issue of Rutland's category 1 response times being consistently poorer than our rural neighbours in the Rutland Integrated Delivery Group some months ago. Figures to November show that Rutland had poorer response performance than rural neighbours, in category 1, in 9 out of 12 months over the last year. The ICB had tried since to get some light shed on this with EMAS. Having made little progress I then requested that the Rutland patients' outcomes be investigated, to understand if having slower average ambulance conveyance for life threatening conditions has led to individual harm.

It has been agreed that EMAS will do a deep dive on recent category 1's to understand;

- a) If there is a real and consistent risk to Rutland patients or if the low numbers for Rutland mean that a single long wait drags down the average disproportionately
- b) If any individual Serious Incidents involving Rutland people have been as a result of slow ambulance response
