# 17.07 Healthwatch Contract: Management Accounts

The Management Accounts to the end of November 2016 were received and noted.

#### 17.08 Health and Social Care Forward Plans (STPs)

The Chair summarised HWR's activities since the publication of the Draft Leicester, Leicestershire and Rutland (LLR) STP in November 2016:

The HWR Board had favoured a collaborative approach to the process in an attempt to support the widest public involvement in the CCG's (Clinical Commissioning Group) engagement and consultation activities, whilst making it clear in that much more clarity and detail is required by the public.

HWR's pre-engagement STP awareness event at Oakham Castle on 8<sup>th</sup> December had received a good turnout. Answers to the 12 Page list of questions raised at the meeting had not yet been received from the CCG, nor had the promised STP executive summary.

The CCG had publicised two engagement events in Rutland on 24<sup>th</sup> January at Voluntary Action Rutland in Oakham and 26<sup>th</sup> January at The Falcon in Uppingham. Formal consultation on the LLR STP is expected from May onwards,for a period of approximately 3 months. Consultation cannot start until after a decision is made on the capital required for implementation and also will have to avoid the period of local government elections .

Suzie Henson-Amphlett raised concern that as Rutland residents are entitled to utilise health care services from surrounding trusts outside LLR, their views must therefore be represented in cross-border feedback on the Northants STP. The Chair took an action to ensure HWR is involved in the consultation on neighbouring STPs.

## 17.09 Survey of health services in Rutland

The HWR survey of primary care services in Rutland commenced on 4<sup>th</sup> January and will close on 1<sup>st</sup> February 2017. Hardcopy surveys were made available in 20 outlets in Oakham, Uppingham and the villages and the online version was made available through the HWR website. Several Volunteers had also supplied hardcopies to clubs, groups and committees etc.

#### 17.10 Young People's Mental Health

NHS England is running a consultation on proposed changes to specifications for the CAMHS Tier 4 services (Child and Adolescent Mental Health Service)

Ann Williams briefed the meeting on the headline proposals that include;

- removal of the existing tier system in favour of a more patient-focused approach using care pathways
- better national co-ordination
- · creation of local multi-disciplinary teams to aid and speed up needs assessments
- ongoing assessment and improved patient feedback
- improved child to adult service transition management

Ann Williams commented that the proposals, if implemented, would go a long way to improving the service, but expressed concern that the necessary ring-fenced funding must be secured first.

It was agreed that HWR through the Chair would respond to the consultation & proposals and that the Chair would take the discussion offline with Ann Williams o craft HWR's response.

# 17.11 Special Educational Needs and Disability (SEND)

Jacqui Darlington reported on the recent review of Rutland County Council's SEND policy published by the council in November 2016.

It was noted that the document is a comprehensive overview of the strategy including measurable outcomes and targets, but with notable perceived weaknesses, namely;

• that the first of the 4 key actions to 'increase child's and parents' involvement' puts families squarely in the centre, yet it is understood within the carer's community that no input to the strategy had been gathered from the children or their carers

 the academic nature of the strategy document renders it difficult to read and assimilate for busy carers

It was suggested that the purpose of the document and the intended audience is not clear at present. Jacqui Darlington and Ann Williams took an action to clarify this with Councillor Foster and request a simplified, user-friendly synopsis if that is not already in the pipeline.

#### Policy and other Papers to be noted by Healthwatch Rutland Jan 2017

Board Members are asked to note the following recent policy and other items which are relevant to the work of Healthwatch Rutland.

#### 1. Chair & CEO appointed to Healthwatch England

Jane Mordue has been appointed Chair of Healthwatch England and Imelda Redmond as National Director.

## 2. Homecare Support – consultation by Rutland County Council

Prior to renewal of contract, a three-month consultation is underway by Rutland County Council on the way domiciliary care services are provided. The Council's homecare consultation runs until March 31st 2017, during which time service users, family members, carers and providers are being encouraged to get involved and have their say. A special listening event is also being held at the Council offices in Oakham on Friday 13th January 2017, from 2.00-4.00pm. The event is for anyone receiving support at home. A questionnaire is being made available at the Council Offices, local libraries & GP surgeries. It can be completed online at <a href="bit.ly/rutlandhomecare">bit.ly/rutlandhomecare</a>. The survey ends on Friday 20th January 2017, after which the Council will produce a set of options for further consultation between February and March 2017.

# 3. STP Engagement Events West Leicestershire CCG

NHS East Leicestershire and Rutland CCG and Healthwatch Leicestershire will be inviting people to find out more about proposals for healthcare in Lutterworth in January ahead of a formal consultation early 2017. Two events are being held at the Wycliffe Rooms, George Street, Lutterworth, Leicestershire, LE17 4ED. The first will take place on Monday 9 January 2017 from 12pm to 3pm and the second on Tuesday 24 January from 6pm to 8.30pm. This follows the publication of the draft Sustainability and Transformation Plan (STP) last month.

#### 4. Tier 4 CAMHS standards. (See main agenda)

NHS England are currently conducting a National Review of Children and Adolescent Mental Health Service (CAMHS) Tier 4. NHS England have opened a consultation for 90 days to gather as much feedback from as many people impacted by these services. This includes professionals and charities that support work with young people and their families.

NHS England have asked Young Minds to produce a survey for young people, parents and carers so that as many voices are heard. Young Minds will also host two interactive workshops with Young People (January 28<sup>th</sup> 2017) and Parents and Carers (January 26<sup>th</sup> 2017)

5. Action to reduce sales of sugar-sweetened drinks on NHS premises. NHS England is consulting until 18<sup>th</sup> January 2017 on proposals to reduce sales of sugary drinks on NHS premises

#### 6. CQC Reports

#### Learning, candour and accountability (Dec 2016)

This national review by the CQC has found that the NHS is missing opportunities to learn from patient deaths and that too many families are not being included or listened to when an investigation happens.

#### Dentistry

After visiting nearly 1000 dental practices of which over 90% met the regulatory standards, the CQC has pronounced dental services safe.

At the same time Healthwatch England published "Access to NHS Dental services – what people told local Healthwatch" which concluded there are still access issues in some areas

#### Regulation development

The CQC is currently consulting on the next phase of its development until February 2017

# 7. Continuing Healthcare

Proposals to revise the CHC strategy including a planned reduction of £24m are awaited from the CCG.

## 8. Ombudsman

A draft bill is being brought forward to bring together the Parliamentary & Health Ombudsman and the Local Government Ombudsman into a new and single public ombudsman service.
